Southside High School is happy that we can provide parking spaces to as many students as possible. The administration does understand that many of our students have a need for personal transportation either for work or other personal reasons. A fee of \$20.00 will be charged for the privilege of parking on campus. If you need an additional hang tag for another vehicle the cost is \$10.00.

In order for a student to have a privilege of parking on campus during the school year, he/she must follow the regulations listed below:

- 1) Display the Southside hang tag on the rear-view mirror so that it is completely visible.
- 2) All students must park in their assigned parking space. Do not park in areas designated for teachers, visitors, buses, or on the grass.
- 3) No student shall back into a parking space. All cars must be facing in the same direction.
- 4) No sitting, eating, or drinking in vehicle on campus. As soon as you arrive on campus, you are required to leave your vehicle and parking area immediately.
- 5) No going back to your vehicle after you have left your vehicle; carry everything you need with you when you leave your vehicle.
- 6) If you are dismissed early from school or have a permanent dismissal and have gone to your vehicle, you are to leave immediately.
- 7) No playing of loud music while on campus or in the campus area.
- 8) All vehicles must stop at all STOP SIGNS; failure to do so will result in the driver getting a ticket.
- 9) No unsafe movement of your vehicle or horseplay will be tolerated.
- 10) The speed limit on campus may not exceed 10 M.P.H.; failure to do so will result in the driver getting a ticket.
- 11) Violation of code of conduct may cause you to lose your parking privileges at SHS.

If any of these regulations are not followed, it will cause your parking privileges on the Southside High School campus to be revoked for a temporary length of time, the remainder of the school year, or permanently.
